IFCA Legislation Committee Update

As many of you are aware, the Legislature met in an abbreviated Special Session a couple of weeks ago. Obviously, this has been a very different legislative session. While they technically convened in Regular Session as well, they effectively completed substantive business in Special Session. When the Senate finally adjourned just after 1:00am, twenty-two bills had passed both houses. It should be noted that all the bills passed this year were part of the special session, meaning they needed to relate to the very narrow qualifications the special session was called to address.

Here are some of the highlights that pertain to the fire service.

HB2096 – Allows certain bids to be opened electronically.

HB2174 – Extends the 9-1-1 Act. Moves NG9-1-1 deadline from 7/1/2020 to 12/31/2021. Moves surcharge deadline from 12/31/2020 to 12/31/2021. Extends the sunset date to 12/31/2021.

HB2455 – Adds Covid as presumptive under workers compensation. For FF/EMT, must have worked during the 14 days prior to contracting Covid. Adds Covid presumption to the Chicago Police and Fire pension articles.

SB0471 – For Public Employees (including firefighters) extends the one-year period to return to work by 60 days if the physical recovery from an injury was hindered by Covid occurring on or after 3/9/2020 and on or before 12/31/2020.

SB0685 – Allows for Counties to delay penalties and interest for property taxes up to 120 days or the month after the Governor's emergency declaration ends. (Note: many Counties have already acted on this)

SB2135 —Codifies current electronic meeting ability for local (not State) government and adopts certain rules. Limited extensions on adoption of municipal appropriation ordinance and annual budget.

As of May 31st, six of the twenty-two bills have been sent to the Governor (he signed one so far). The remaining bills are still being processed. The Governor is expected to sign all the bills.

The chambers adjourned the Spring Session, with the next scheduled date on November 17th (veto session) or by special call. The Legislature did not pass legislation allowing for their own electronic meeting, so any further legislative action would need to take place in person in Springfield. While this was a very interesting end of session, it will be just as interesting to see where this goes in the next few months.

To the Members and Partners of the Illinois Fire Chiefs Association:

Going into 2020, there was great anticipation for the IFCA's 50th Annual Symposium and 70th Annual Conference. Unfortunately, COVID-19 hit. The cancellation of the Symposium was disappointing, but not surprising, with the state mandates that went into effect.

Our attention then turned to the Conference. Contact was made with the Peoria groups, a few of our sponsors and vendors, as well as our members. The overall result of these communications was: we don't know! The list of unknowns for us include:

- If a resurgence of the virus will occur in late summer, early fall.
- If the state mandates will allow groups of more than 250 people to gather at that time.
- If the vendors and sponsors would be in attendance.
- If financial constraints and/or directives on travel by communities would affect the attendance of the Fire Chiefs themselves.

Due to these unknowns, the decision has been made to cancel the IFCA's 70th Annual Conference, which was scheduled for October 11-14, 2020.

The decision at this point was not taken lightly – but the time was right. The longer the Conference Committee continued planning, the cash outlay would begin to increase and more likely not be recoverable.

In the coming weeks and months, more information will become available regarding electronic voting, a virtual oath of office, business report(s), etc.

Please bear with us through these unprecedented times. We look forward to the future, and next year's Symposium and Conference.
