PHMSA has taken a leadership role to help states discuss and implement a collaborative Pipeline Emergency Responders Initiative (PERI).

#### PHMSA's Goals for a PERI Program:

- Improve communication between emergency responders and pipeline operators nationwide, an important component of pipeline safety.
- Strengthen relationships among all various stakeholders involved with pipeline safety and emergency response.
- Spur the development and implementation of enhanced pipeline emergency response training.

## WHO WOULD BE INVOLVED IN A STATE PERI?

PERI participation is open to all stakeholders with an interest in protecting people and the environment from the risks inherent in transporting hazardous material through pipelines.

## BACKGROUND: REGULATORY REQUIREMENTS

#### **Emergency Plans** - 192.615 and 195.402

- Establish and maintain liaison with appropriate fire, police, and other public officials
- Written procedures for notifying appropriate fire, police, and other public officials of gas and liquid pipeline emergencies
- Acquaint the officials with the operator's ability in responding to a pipeline emergency
- Plan for how the Operator and Officials can engage in mutual assistance

#### Public Awareness - 192.616 and 195.440

- Develop and implement education programs for key stakeholders, including emergency responders
- Appropriate messages to emergency responders and public officials





### BACKGROUND: FIRE MANAGEMENT REQUIREMENTS

Fire Chiefs are assigned the responsibility of ensuring as safe an environment as possible for emergency responders under their command.

Includes sharing information about pipeline emergencies:

- Within their agency
- With other agencies,
- With Pipeline Operators
- With the public.

#### Fire Chief Officers have an obligation to:

- Know if pipeline facilities exist within their respective territories
- •Understand the associated hazards
- Have emergency response procedures to address those risks





#### **IPERI'S MISSION**

To advance the abilities of emergency responders and pipeline operators in Illinois to manage pipeline emergencies through improved training, cooperation, communication, and collaboration.









#### **IPERI GOALS AND OBJECTIVES**

- Improve and sustain effective communication between emergency responders and pipeline operators
- 2. Increase emergency responders' awareness of pipelines in their jurisdictions
- 3. Establish a baseline to evaluate pipeline emergency response preparedness
- 4. Identify weaknesses in existing regulatory and emergency response programs and develop collaborative solutions
- 5. Develop a sustainable, comprehensive pipeline emergency response training program





#### WHAT IPERI IS...AND IS NOT

- IPERI IS: a public-private partnership among emergency response organizations and pipeline operators to improve emergency response
- IPERI IS NOT: a substitute for individual pipeline operator liaison activities
  - Operators still need to share companyspecific information about their assets, risks and hazards
  - Need to discuss how operators and responders will cooperate in a pipeline emergency





## WHERE ARE WE NOW? OUR PROGRESS...





#### TIMELINE

- 2012 Georgia develops a state PERI and PHMSA identifies a best practice
- December 2020 IPERI Steering Committee was formed
- Early 2021 Talks began with the IFCAERF to join under their nonprofit
- During 2021 Developed a roadmap "Progress Continuum" and continued our work
- January 2022 IFCAERF board passed a resolution to stand up the IPERI Committee
- March 2022 Steering Committee planned transition to IPERIC
- August 2022 IFCA Board appointed Emergency Responder members of the IPERIC
- September 2022 Last meeting of the IPERI Steering Committee; Pipeline members voted to IPERIC
- February 2023 Inaugural meeting of the IPERI Committee

- Recommending IPERI membership assessments based on number of services for investor- and municipal-owned utilities and based on number of counties for interstate pipelines


