The Village of Oak Park, Illinois (Pop. 54,583) is seeking an experienced and dynamic Fire Chief to lead its highly respected fire department. This is an exceptional opportunity for a dedicated fire service professional to make a lasting impact on public safety in one of the state's most vibrant and diverse communities.



About Oak Park

Located just nine miles west of downtown Chicago, the Village of Oak Park offers a distinctive urban/suburban lifestyle in a thriving, multi-cultural community. Well-known for progressive values, tree-lined streets and bustling business districts, Oak Park serve as an ideal place to live, work and play. As a longstanding community of choice, the Village benefits from convenient access to local and regional transit, high quality public schools, and arts and cultural attractions including Frank Lloyd Wright's home and studio and his acclaimed Unity Temple, which was recently designated as a UNESCO World Heritage Site.

About the Position & Department



The Oak Park Fire Department is a full-service, professional department dedicated to protecting lives and property through fire suppression, emergency medical services, fire prevention and public ed-

ucation. The department operates from three fire stations and provides advanced life support (ALS) emergency medical services. Approximately 64% of the Fire Department calls are for emergency medical service, and 36% are fire calls or other calls for service.

The Fire Chief oversees three shifts of 22 personnel. Each shift has a Battalion Chief in charge of the shift with four Lieutenants who serve as company officers and 17 Firefighter/ Paramedics who staff three ambulances, two engines, a ladder truck, and the command vehicle. The total operating budget across Administration, Operations, EMS, Fire Prevention and Training & Public Education is over \$13M.

The Fire Chief is responsible for assuming full management responsibility for all Fire Department services and activities, managing the development and implementation of Fire Department goals and objectives, and establishing, within Village policy, appropriate service and staffing levels within the department.

In addition to providing world class baseline services, identified priorities for the new Fire Chief will include:

- Comprehensive review of staffing and services levels
- Review of Fire Department capital needs
- Review of Departmental overtime utilization
- Workforce Diversity Planning
- Implementation of Village's Alternative Response to Calls for Service Pilot Program











Minimum Qualifications

Candidates must have seven years of broad and increasingly responsible fire suppression, emergency medical and related experience, including a minimum of five years of administrative and supervisory experience.

Candidates must have an Associate's Degree in Fire Science, or a Bachelor's Degree from an accredited college of university with major coursework in fire science, public administration, or a closely related field, or have more than 10 years of service as a firefighter in the Village of Oak Park.

All candidates must possess or have the ability to obtain a Valid Illinois Driver's License and possess or have the ability to obtain the following State requirements:

- Basic Operations Firefighter Certification or Firefighter II Certification
- Advanced Fire Officer Certification or Fire Officer II Certification
- A current certification that meets the National Fire Protection Association
 (NFPA) standards NFPA 1001
- A current certification that meets the NFPA standards NFPA 1021
- Qualifications that meet requirements of the NFPA's standard NFPA 1001, Standard for Fire Fighter Professional Qualification, Level I, job performance requirements and standard NFPA 1021, Standard for Fire Officer Professional Qualification, Fire Officer II job performance requirements.

Compensation & Benefits

The Village of Oak Park offers a highly competitive benefits package that includes Oak Park Fire pension participation, health and life insurance, vacation, sick leave and other benefits including flexible working arrangements. The annual salary range for the Fire Chief is \$134,310.00 - \$194,750.00 with the anticipated hiring salary of \$170,000 +/- depending on qualifications.
